Special Family Membership Fee:

\$25.00 per each additional adult child who resides out of town

The special membership fee above allows a member to bring his adult child(ren) (*who reside out of town*) on the range to shoot up to (4) times per year with the member present. The eligible children shall be listed by name on the annual application for membership and listed again on the current member's ID badge. (i.e. 1 adult child - \$25.00; 2 adult children - \$50.00; 3 adult children - \$75.00, etc.) ***The above special membership fee is in addition to the current membership fees listed above.***

**A membership year begins on April 1 and ends on March 31 of each year.** Membership fees are not prorated. However, any new member who joins between January 1 and March 1 and pays his/her dues shall be considered paid in full for the following membership year. ***Current National Rifle Association (NRA) membership is required to qualify for the Butte Gun Club NRA membership fees.***

Family Memberships are reserved for the Primary Member and Spouse and include a family's minor children (children who are under the age of eighteen who typically reside in a single household with a parent(s)). All minor children must be accompanied by a parent in possession of a current family membership when using the range. ***Children of a family who are eighteen years and older residing in town must have their own individual membership in the club.***

**RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS AND ASSUMPTION OF RISK AGREEMENT**

**WHEREAS**, in return for instruction in firearms, use of premises, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned agrees to the following:

The Undersigned shall **indemnify, hold harmless and defend** the Butte Gun Club, and any of its employees, directors, officers, contractors, agents and any people or entities similarly situated, from any and all fault, liabilities, expenses, claims, lawsuits, or other similar matters, arising out of, or related to or connected with the discharge of firearms; the Undersigned's participation in the use of the range and premises; the Undersigned's presence on or use of said Premises; and any and all acts or omissions of the Undersigned. And should any such matter arise or be asserted in any way whatsoever related thereto, under any theory of law or equity, the Undersigned shall **indemnify, hold harmless and defend** the Butte Gun Club, from any and all costs, expenses or liability including but not limited to, the cost of any settlement or judgment made or rendered against the Butte Gun Club, whether individually or jointly with the Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such matter, including attorney fees.

The Undersigned furthermore **waives** for himself/herself and his/her executors, administrators, assignees or heirs, any and all rights and claims for fault, liabilities, claims, lawsuits or any similar matters, which he/she may have or which may arise against the Butte Gun Club, (including, but not limited to any and all injuries, damages or illnesses suffered by the Undersigned or the Undersigned's property), which may, in any way whatsoever, arise out of, be related to or be connection with: the use of the Premises, including any latent defect in the Premises; the Undersigned's presence on or use of said Premises; the Undersigned's property (whether or not entrusted to the Butte Gun Club); or the discharge of firearms. **Butte Gun Club shall not be liable** for, and the Undersigned on behalf of himself/herself and his/her executors, administrators, assignees or heirs, hereby expressly releases the Butte Gun Club from any and all such claims.

The Undersigned hereby expressly assumes the risk of entering the Premises and of taking part in activities on the Premises which include, but are not limited to, instruction in the use of firearms, the discharge of firearms, and the firing of live ammunition.

Your license and permission to enter this range property is limited in scope to participating in shooting and related activities on the property. Shooters and visitors at this range are strictly prohibited from: 1) Collecting or removing any soil, water, or air samples from any location on the range; and 2) Removing any items or materials from the range that you did not bring to the range or purchase at the range. Violators will be ejected, and may be subject to arrest and prosecution.

This instrument binds the Undersigned and his/her executors, administrators, assignees or heirs. In the event that any portion of this document is deemed unenforceable, the other portions shall be enforced in a manner which best serves the original intent of the parties.

The Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all Butte Gun Club range rules and procedures.
